Instructors/Tutors currently employed in the Education and Library Boards Transfer from Teacher Related Scales to JNC Youth and Community Workers Scales

Further to JNC Circular No 134, the Joint Secretaries of the Joint Negotiating Council, have agreed assimilation arrangements for Instructors /Tutors transferring to the JNC Youth and Community Workers Scale (Professional Range, Points 23 - 26) with effect from 1 August 2002.

Assimilation arrangements are detailed as per the attached appendix. It should be noted that staff on the maximum point of the salary scale at 01.04.02 shall be afforded 'personal to holder' protection until 01.03.03.




